

## **VOLUNTEER LIABILITY WAIVER (Updated March 2016)**

I, in consideration of my voluntary participation in SALP activities, offered/sponsored by Portland State University ("PSU"), do hereby assume full responsibility for all risk of injury or loss which may result from my participation in Activity. I acknowledge that I have read and understand all the information provided by PSU concerning this Activity.

I agree to hold harmless, release and forever discharge Portland State University, its officers, agents, Board members, and employees from any and all claims and demands whatsoever which I or any third party may have against them by reason of any accident, illness, injury, or death, or damage to, or loss of, or destruction of property arising or resulting directly or indirectly from my participation in Activity.

I understand, agree and acknowledge that some activities may include physical or strenuous activity that may result in illness, personal injury, suffering or possibly death and I understand and appreciate the nature of such hazards and risks. Additionally, some activities may require traveling in buses or other approved methods of transportation. Understanding the above, to the best of my knowledge, I have no medical, physical, mental, or emotional health conditions that would hinder my participation in this Activity, unless so stated in writing by me prior to the date of Activity.

In the case of an emergency, if I am unable to effectively communicate, I authorize the staff of PSU to obtain whatever medical treatment deemed necessary for my welfare. I further understand and agree that I will be financially responsible for all charges and fees incurred in the rendering of said emergency treatment, regardless of whether my medical insurance would cover such charges and fees.

I agree that this Consent and Release Agreement shall be construed in accordance with the laws of the State of Oregon and that the venue for any legal proceeding arising out of this agreement shall be in Oregon. If any term or provisions of this Consent and Release Agreement shall be held illegal, unenforceable, or in conflict with any law governing this agreement, the validity of the remaining portions shall not be affected thereby.

I understand that PSU reserves the right to remove me from participation in this Activity at any time should my actions or behavior, in the sole discretion of PSU, impede or obstruct the activities of other participants in the Activity or if my actions or behavior endanger me, other participants, faculty, staff or Activity representatives.

I represent and acknowledge that I am at least eighteen (18) years of age or, if not, that Participant has secured the additional signature of a parent or legal guardian.
